COMMUNICATIONS FROM AUDIENCE:

MR. SAVON ASKED STATED RESIDENTS ON FIXED INCOMES FIND IT DIFFICULT TO ENDURE ANY INCREASE IN TAXES AND WHY ARE TAXES GOING UP. KETURI RESPONDED COSTS SUCH AS, FUEL, INSURANCE, ELECTRIC, ETC. CONTINUE TO CLIMB AND TOWN BOARD HAS KEPT BUDGET UNDER 2 % FOR SEVERAL YEARS. SHOEMAKER EXPLAINED THIS LOCAL LAW IS INTENDED TO INFORM PUBLIC REGARDING EXCEEDING 2% TAX CAP AND NO FINAL BUDGET HAS BEEN APPROVED.

MR. WHEELER EXPRESSED HIS DISSATISFACTION WITH TOWN'S BUDGET INCREASES AND FEELS REWORKING HIS ROAD SEVERAL TIMES IS NOT COST EFFICIENT. KETURI EXPLAINED HE'S BEEN WORKING ON BUDGET SINCE AUGUST AND UNDERSTANDS CONCERN.

MR. KASTENHUBER QUESTIONED MODE OF ADVERTISING MEETINGS AND SWAYZE, JR. HAS INDICATED ALL MODES OF NYS REQUIRED ADVERTISING WERE FOLLOWED (INCLUDING TOWN'S LED SIGN AND WEBSITE). MR. KASTENHUBER ASKED ABOUT SHARED SERVICES AND EASTWOOD INDICATED WE CURRENTLY PARTICIPATE IN SHARED SERVICES. HE EXPRESSED HIS DISSATISFACTION WITH UPCOMING REEVALUATION.

MS. FRICK NOTED TOWN HIGHWAY DEPARTMENT HAS AN ABUNDANCE OF EQUIPMENT FOR TOWN OUR SIZE. MS. FRICK STATED WATER DEPARTMENT SEEMS TO EMPLOY TOO MANY EMPLOYEES AT THIS TIME AND RAISES HAVE BEEN TOO MUCH IN PAST. MS. FRICK NOTED TOWN COULD ADVERTISE IN OWEGO

MS. WRIGHT ASKED IF TOWN WAS UTILIZING ALL EQUIPMENT AND NYS OGS. EASTWOOD SAID YES, TOWN UTILIZES EQUIPMENT AND OGS. MS. WRIGHT ASKED IF TOWN HAS PROCUREMENT POLICY; SHOEMAKER RESPONDED YES. MS. WRIGHT STATED BUILDING CODE OFFICER SHOULD BE WORKING ON HOMEOWNERS TO ADHERE TO KEEPING THEIR RESIDENCE IN COMPLIANCE WITH NYS BUILDING CODE LAWS.
